We agree to remain completely liable for any duties and taxes owing to CBSA until they are paid in full either by us or USAV Customs Brokers.

We agree to keep our own records of any transactions completed by USAV Customs Brokers at our place of business in Canada.

We agree to allow USAV Customs Brokers to appoint a sub-agent when and where it sees fit.
